

Confirmation of Veterans Affairs Benefits for Eligible Recipients

Our Office of Admissions has deemed your current residency status as a "non-resident". Our TCL Residency & Veterans Affairs Offices must confirm that you have applied and are indeed eligible to receive specific benefits based on your current status to grant you "in-state tuition", regardless of your formal state of residence. This policy complies with Title 38 United States Code Section 3679(e) School Compliance Form. This policy pertains to a Covered Individual, which is any individual who is entitled to educational assistance under Chapter 30 – Montgomery G.I. Bill® - Active Duty (MGIB-AD, Chapter 31 – Veterans' Readiness and Employment Program® (formerly VA Vocational Rehabilitation), or Chapter 33, Post 9/11 GI Bill® benefits.
